Nippon Paint Holdings Co., Ltd. completed its group reorganization on April 1, 2015.

"Nippon Paint Co., Ltd." (established on October 1, 2014) was split off into four separate companies by business segment (automotive coatings, industrial coatings, trade-use paints and surface treatment chemicals) and these four companies were merged with some domestic subsidiaries related to respective businesses.

The purposes of this reorganization is to strengthen the unification of value chains in each business as well as to attain efficient operations by streamlining overlapped functions within the group.
